The Guarantor's liability hereunder shall not be prejudiced or impaired or affected by *any* renewal or extension which may be made of the time or terms of payment by the Principal, or by any forbearance or delay in enforcing the payment of the account, or by any modification of the terms of provisions of the account.
3.
